**ORDER GRANTING TRUSTEE'S EX-PARTE  
APPLICATION FOR AN ORDER AUTHORIZING THE EMPLOYMENT  
OF KOZYAK TROPIN & THROCKMORTON, P.A. AS COUNSEL**

On May 26, 2010, Drew Dillworth, the Chapter 7 Trustee ("Trustee") for the bankruptcy estate of Antoine Walker ("Debtor"), filed an *ex parte* motion pursuant to 11 U.S.C. § 327(a), Fed.R.Bankr.P. 2014, and Local Rules 2014-1 and 9013-1(C)(3) for an order authorizing the employment of the law firm of Kozyak Tropin & Throckmorton, P.A., 2525 Ponce De Leon, 9<sup>th</sup> Floor, Coral Gables, Florida 33134, to represent the Trustee in this case. Without conducting a hearing the Court considered the matter on the papers submitted.

Upon the representations that Kozyak Tropin & Throckmorton ("KT&T") is qualified under Local Rule 2014-1(A) to practice in this Court, that KT&T holds no interest adverse to the estate in

the matters on which they are engaged, and that KT&T are disinterested persons as required by 11 U.S.C. § 327(a), and have disclosed any connections with parties as required by Fed.R.Bankr.P. 2014, and that their employment is necessary and would be in the best interests of the estate, it is –

**ORDERED** that the Trustee's application is **GRANTED**. The Trustee is authorized to employ the law firm of Kozyak Tropin & Throckmorton, P.A. as attorneys for the Trustee in this case pursuant to 11 U.S.C. §§ 327 and 330.
